Pursuant to the provisions of *The Alcohol and Gaming Regulation Act, 1997*, the Saskatchewan Liquor and Gaming Authority (SLGA) has approved your application for the following liquor permit(s).

This permit must be prominently displayed in the premises for which it is issued.

Please note that this permit expires 2022. The fee received this year was for one year therefore, you will receive a reminder invoice next year to submit further fees to keep the permit valid. Please keep in mind any proposed renovations to the establishment or changes to the company must be reported to SLGA.

It is a term and condition of your liquor permit that your permit number be used when purchasing beverage alcohol for resale in your outlet. This includes inserting the number in the proper place on each beer order in accordance with Brewers Distributor Ltd. instructions. Failure to use the assigned permit number for your alcohol purchases may result in sanctions against your permit, which may include a fine, suspension or cancellation of your permit.

During the term of your permit, it is important that you report to SLGA all changes to your application, including any criminal charges, investigations, and/or convictions. Failure to comply with this requirement may also result in sanctions against your permit.

SLGA asks that you make every effort to maintain a high standard of operation and observe both the spirit and letter of *The Alcohol and Gaming Regulation Act, 1997*.

SIRS Certification is required for all owners and paid employees who are involved in the sale and service of beverage alcohol. Please ensure that you maintain a copy of the certification onsite.

In order for a commercial permittee to purchase beverage alcohol products without LCT from a liquor retail store, they must have a commercial liquor permit issued to them by SLGA. This permit must be valid and in good standing before a commercial permittee is authorized to purchase and re-sell beverage alcohol. From time to time some commercial permittees encounter situations where SLGA suspends their permit which results in them not being able to purchase or sell beverage alcohol for the duration of the suspension.

As a retail store permittee, you are obligated to ensure the commercial permittee has a liquor permit in good standing. In order to assist you with this process SLGA maintains a list of all commercial permittees who are currently serving suspensions on our website (www.slga.com) that only retail store permittees have access to. In order to access this list, you must first register as an online user (if you have not already done so) after which you will be granted access to the list of commercial permittees currently serving suspension. In order to access the suspension list please go the SLGA home page, log in as a registered user and navigate to the following link:

Once at this location, you will see a list of all the commercial permittees currently serving a suspension that you are not allowed to sell beverage alcohol to. For clarity, commercial permittees include other retail stores, restaurants, taverns and special use permittees.

is hereby authorized to purchase beverage alcohol from the Saskatchewan Liquor & Gaming Authority (SLGA) and to sell that beverage alcohol in accordance with the provisions of *The Alcohol and Gaming Regulation Act, 1997*, and *The Alcohol Control Regulations, 2016*, and all conditions prescribed by SLGA during the maximum time and in the areas described below:

MAXIMUM HOURS OF SERVICE

Subject to local bylaws that may reduce these hours:

- Daily 8:00 am to 3:00 am.
- Dec 31 8:00 am to 3:30 am.

PERMIT CONDITIONS

- Advertising and promotions must not target minors or promote overconsumption of beverage alcohol.
- All operations must comply with policies established by SLGA as outlined in the Liquor Permittee Manual and as may be amended from time to time. The Manual is available for viewing and download at www.slga.com.
- Limited Time Offers 100% of discounts resulting from in-store LTOs negotiated with suppliers must be passed on to customers.
- Minors may be allowed to enter integrated and transitional retail store premises unaccompanied, unless the premises are co-located with a business that is subject to a minors-prohibited permit such as a tavern or restaurant lounge. In that case, minors are prohibited.
- Minors may be allowed to enter stand-alone retail store premises as long as they are accompanied by their parent, legal guardian, or spouse of legal age.
- Minors may be allowed to enter the premises unaccompanied in order to provide emergency maintenance to the premises.
- Minors must not sell, purchase, or handle beverage alcohol in any manner.
- Re-sale levy The permittee is responsible for collecting and remitting the re-sale levy on beverage alcohol sales to all sale special occasion permit holders.
- Record keeping must meet the minimum requirements as outlined in Chapter IX of the Liquor Permittee Manual.
- Server intervention training All individuals involved in the sale and service of beverage alcohol must be certified in a recognized server intervention training program according to the schedule outlined in Chapter XI(3)(e) of the Liquor Permittee Manual.
- Social Reference Price All beverage alcohol sales to retail customers and special occasion
 permittees must comply with Social Reference Pricing policies established by SLGA as outlined in the
 Appendix to the Liquor Permittee Manual.
- Store closure Without prior approval from SLGA, retail store permits that are inactive for a period of 90 days or more will be void.
- Warehousing Beverage alcohol must be securely stored at the permitted premises or at another warehousing facility approved by SLGA.

EFFECTIVE: April 25, 2019

EXPIRES: April 24, 2022

This permit becomes void should the premises be sold, leased, assigned or otherwise transferred to the control of another person. This permit must be prominently displayed in the premises for which the permit is issued.
